TERMS AND CONDITIONS

- 1. Information on how to enter, and the prize form part of these Terms and Conditions.
- 2. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 3. The Promoter is National Basketball League (ABN 65 164 187 937) of Level 6, 10 Queens Road, Melbourne VIC 3004 (**Promoter**).
- 4. If you are an Eligible Person and satisfy all Entry Requirements then subject to these Terms and Conditions, you will be entered into the competition (**Promotion**).
- Entries into the Promotion open at 9:00am (AEDT) on 19/12/22 and close at 7.30pm (AEDT) on 22/12/22 (Entry Period) and the Promotion will run until 7.30pm (AEDT) on 01/01/2023 (Promotional Period).

Eligibility and Entry

- 6. Entry to the Promotion is only open to individuals who (**Eligible Person**):
 - a. are permanent Australian and New Zealand Residents aged 16 years or older, excluding employees (and their Immediate Families) of the Promoter and agencies associated with this promotion (and their Immediate Families). - 12. , 7:30pm AEDT; Adelaide 36ers v Brisbane Bullets, Thursday 29 December, 7:30pm AEDT; Sydney Kings v Tasmania JackJumpers; Friday 30 December, 7:30pm AEDT; Illawarra Hawks v Perth Wildcats, Saturday 31 December, 5:30pm AEDT; Cairns Taipans v Adelaide 36ers, Saturday 31 December, 8pm AEDT; Tasmania JackJumpers v S.E. Melbourne Phoenix, Sunday 1 Januart, 2pm AEDT; Brisbane Bullets v Melbourne United, Sunday 1 January, 4pm AEDT. In the event of a tie, the Eligible Person with the most accurate margin of victory prediction across the 12 games will be deemed the winner. In the event that this is a tie, the Eligible Person who signed up to the Promotion first will be named the winner.
- 13. Following the Promotional Period, the winner will be determined by the Promoter, based on each Eligible Entrants' results of the tipping competition.
- 14. The prize will be delivered to the winner by courier or post when the relevant jersey has been manufactured and is available. The prize cannot be redeemed for cash and is not transferrable.
