

Terms and Conditions for 21-22 Sydney Kings Membership ‘Win a training session for Dad’ Competition

I

By entering into the Competition, you are agreeing to the following terms and conditions:

Competition Period:

The Competition commences at 09:00am (AEST) on Saturday 21st August 2021 and closes at 11:59pm (AEST) on Sunday 5 September 2021 (“the Competition Period”).

If for any reason the Competition is not capable of running as planned due to any reason beyond Sydney Kings control, it reserves the right (subject to any applicable law), in its sole discretion, to cancel the Competition.

Eligibility

Subject to the below, entry into the Competition is open to all 2021-22 members who purchase a 2021-22 membership during and prior to the designated competition period from 15 July 2021. For the sake of clarity this includes members who have renewed their memberships between 15 July and 5th September August 2021.

Entry is not open to employees and immediate family members of employees of the Sydney Kings.

Entry

Incomplete, indecipherable or illegible entries, and those that are considered unlawful, harassing, defamatory, abusive, threatening, obscene, sexually orientated, racially offensive or contain objectionable content or are otherwise inappropriate (“Invalid Entries”), will be deemed invalid and will be rejected. The determinations in this regard are at Sydney Kings absolute discretion and discussions will not be entered into.

Sydney Kings reserves the right to verify the validity of all entrants and entries, and further reserves the right to disqualify any entrant for submitting an entry that is not, in Sydney Kings absolute discretion, in accordance with these Terms and Conditions.

Sydney Kings are not responsible for any lost, late or misdirected entries.

As a condition of entering into this Competition, each entrant agrees to participate and co-operate as required in all editorial activities relating to the Competition (including but not limited to, being photographed and interviewed) and grants to Sydney Kings a perpetual, irrevocable, royalty-free licence to use such footage and photographs and their entry in any media (including, but not limited to, banners, signage, posters, television, magazine, internet, MMS, DVD or other digital or print formats) for an unlimited time for any reason.

Winning

Members who have purchased at least one 7-Game or Full Season membership will be entered into the draw. There will be one (1) winner in total, chosen at random.

The winner will be selected via a random draw.

1 entry per Primary Account Holder with at least one membership purchased up until 11.59pm Sunday 20th August.

The random draw will be performed by the Sydney Kings membership team.

The winner will be:

Contacted by phone call, text message and/or email before 5pm 12th September 2021, at which point they will be offered the prize for their dad or guardian. Another family member can be offered the prize at the discretion of Sydney Kings management.

Should the winner decline the prize a new winner will be drawn and the process repeats until a member accepts the prize.

Prizes

The one (1) winner will receive the opportunity to attend a training session with the Sydney Kings. The training session will only take place when deemed safe under NSW Health public health orders. This means that the training session may not take place for up to 12 months.

The training session will not include actual scrimmage with Sydney Kings players so as to avoid the possibility of injury for both the winner and Sydney Kings players. It will include a warm up, warm down, skills session and the opportunity to meet the players and Kings coaching staff.

Any additional costs incurred in claiming and redeeming the Prizes (including, but not limited to travel, food and accommodation costs) are the sole responsibility of the winners.

The Prize is not redeemable for cash and is not transferrable or exchangeable.

The winner may be required to present photo identification when they collect their Prize.

As a condition of accepting the Prize, the winner may be required to sign any legal documentation as and in the form required by Sydney Kings in its absolute discretion, including, but not limited to, a legal release and indemnity form.

The prize winner will be subject to and must abide by the terms and conditions of any third parties, including but not limited to the venues the winner will attend.
